

## “Prevent” Action Plan

Houghton Primary School recognises that it has a duty under Section 26 of the Counter-Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism. At Houghton Primary School the Designated Prevent Lead is the headteacher.

<b>Staff training</b>			
Equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas.	Assess the training needs of staff in the light of the school’s assessment of the risk to pupils at the school of being drawn into terrorism.	<ul style="list-style-type: none"> <li>The school has ensured that the designated safeguarding lead AND the deputy headteacher have undertaken Prevent Awareness Training.</li> <li>The designated safeguarding lead is able to provide advice and support to other members of staff on protecting children from the risk of radicalisation.</li> </ul>	<b>Designated Safeguarding Lead/Prevent Lead</b>
